

**Idaho State Board of Medicine
Regular Meeting
June 5, 2015**

Chairman Robert Ward, MD, Twin Falls, called the Idaho State Board of Medicine (Board) meeting to order at 1:09 p.m. Friday, June 5, 2015 at the Holiday Inn Express, Parkcenter Room, 475 West Parkcenter Blvd. Boise, Idaho, 83706. MINUTES

The Board reviewed and approved the minutes of the March 6, 2015 regular meeting. (Williams/Unanimous)

Unless otherwise noted, all actions were taken on motions duly made and adopted unanimously.

ADMINISTRATION

The Board reviewed and discussed the financial report. In further action the Board approved the expenses of the executive director. (Brown/Unanimous)

The members reviewed the quarterly report of the Physician Recovery Network (PRN)

The Board considered five candidates for the Committee on Professional Discipline and acted to appoint William Ganz, MD, Coeur d'Alene. (Brown/Unanimous) In further action, the Board acted to appoint Barry Bennett, MD, Idaho Falls to the COPD. (Williams/Unanimous)

The Board considered candidates for the COPD chairman position and acted to appoint Laura McGeorge, MD, Boise, as Chairman. (Sutherland/Unanimous)

The Board members considered a letter from Senator Dan Schmidt and the Multiboard Statement of Understanding Regarding the Prescribing of Controlled Substances brought forward by the Office of Drug Policy. The Board acted to support the statement. (Chadwick/Unanimous)

The members discussed information on the annual Federation of State Medical Boards (FSMB) meeting in Fort Worth, Texas April 23-25, 2015 presented by Chairman Robert Ward, MD.

Chairman Robert Ward, MD, volunteered to write an article for the newsletter.

The Board reviewed highlights of changes to the National Practitioner Database reporting requirements for state medical boards.

The members reviewed the annual report to the Idaho Medical Association.

LEGAL

The members were updated on the status of the Board's legislation on the Interstate Medical Licensure Compact (HB150) signed by the Governor on March 25, 2015. In further discussion, the Board acted to nominate Robert Ward, MD, and Anne Lawler, Quality Assurance Specialist as candidates for the Commission to be formed under the compact legislation. The nominations will be forwarded to Governor. (Brown/Unanimous)

The members reviewed the rule drafts for International Medical Graduates (IMG) that have been reviewed and approved by the subcommittee members in the negotiated rule making process. The Board directed staff to continue the rule promulgation process. (Sutherland/Unanimous) The Board also reviewed draft rules for telemedicine in accordance with HB 189, Telehealth Access Act. The Board directed staff to continue the rule promulgation process. (Chadwick/Unanimous)

Jean Uranga, Board attorney, updated the members on the status of litigation in Holley V. Board of Medicine, Pines v. Board of Medicine, and gave a brief overview of the U.S. Supreme Court decision in the Federal Trade Commission v. the North Carolina Board of Dental Examiners.

LICENSURE

The Board acted to approve all licensure and registration actions taken subsequent to the last Board meeting on March 6, 2015 as noted on the attached licensure report. (Sutherland/Unanimous) (Appendix 1)

The Board considered an application for wavier to allow a physician at Saltzer Medical Group, Urgent Care Clinic to supervise six physician assistants as his predecessor in that position had done. The Board, after discussion and consideration, acted to approve the wavier for one year until another physician could assume supervision and come into compliance with the rules for the supervision. (Williams/Unanimous)

The Board acted to require completion of an approved re-entry program and SPEX examination as condition of licensure for applicant BOMA 5447. (Sutherland/Unanimous)

The Board reviewed information on the withdrawn application of BOM 4799.

The Board reviewed the minutes of March 2, 2015 meeting of the Board of Athletic Trainers, the March 19, 2015 minutes of the Dietetic Licensure Board, the May 1, 2015 minutes of the Physician Assistant Advisory Committee, and the April 16, 2015 meeting of the Respiratory Therapy Licensure Board.

Chairman Robert Ward, MD adjourned the Board of Medicine meeting at 2:34 p.m. on Friday, June 5, 2015.
