PARTICIPATING:

The meeting was called to order at 3:05 PM by Chairperson Corliss Trom, RD, Meridian. Participating by phone were: Samantha Ramsay, RD, Coeur d'Alene; and Patti Copple, Nampa. Veena Sohal, RD, Idaho Falls was absent and excused. Also present were Board of Medicine staff members: Nancy Kerr, Executive Director and Jodi Adcock, Technical Records Specialist I.

Rebecca Swartz, LD, RD, of the Idaho Dietetic Association (IDA), attended as a guest for the open session of the Board meeting.

MINUTES:

The minutes of the Dietetic Licensure Board's (DLB) March 8, 2011 meeting were approved. (Copple/Unanimous)

BUSINESS:

The DLB discussed and approved the proposed Administrative Rule changes for the 2013 legislative session. (Copple/Unanimous)

The DLB was updated regarding current licensure count. Dietitian initial licensure: 435; Dietitian inactive licensure: 1; Graduate Dietitian Provisional licensure: 0. (Information)

The DLB reviewed their Financial Status Report.

The DLB was updated regarding the legislative changes for the 2012 legislative session. Members directed staff to continue the legislative process. (Consensus)

The DLB reviewed a letter from the Commission on Dietetic Registration regarding revised test specifications. (No action required)

The DLB read a report from Mary Leonard, associate director for the Board of Medicine, regarding a recent IDA meeting and the interest of the IDA to have a representative attend DLB meetings.
