PARTICIPATING:

The meeting was called to order at 4:05 PM by Chairperson Samantha Ramsay, Moscow. Participating by phone were: Becky Sulik, RD, Idaho Falls and Patti Copple, Nampa. Corliss Trom, RD, Meridian was absent and excused. Also present were Mary Leonard, Associate Director and Jodi Adcock, Technical Records Specialist I. Connie Lorenz, RD was present during the public portion of the meeting as the licensure liaison from the Idaho Academy of Nutrition and Dietetics.

MINUTES:

The minutes of the Dietetic Licensure Board's (DLB) October 17, 2012 meeting were approved. Unless otherwise noted, all actions were taken on motions duly made and adopted unanimously. (Motion-Copple; Affirmed-Unanimous)

BUSINESS:

Upon deliberation and discussion, the DLB voted to have the next meeting on October 9, 2013 at 4:00 P.M. Mountain Time. (Motion-Ramsay; Affirmed-Unanimous)

The DLB reviewed their Financial Status Report. (No Action Required)

The DLB reviewed the amendments to IDAPA 22.01.03 and discussed implementation of the fee increase. The DLB approved increasing the licensure fees beginning as soon as approved by the Legislature. (Motion - Copple; Affirmed-Unanimous) The increases were approved as follows:

Initial Licensure from \$80 to \$100  
Provisional Licensure from \$80 to \$100  
Renewal from \$45 to \$60  
Inactive Renewal from \$25 to \$30  
Reinstatement from \$35 to \$40

DISCIPLINE:

There were no disciplinary cases to consider.
