Idaho State Board of Medicine
Regular Meeting
June 6, 2008

Chairman Stephen Marano, MD, called the meeting to order at 10:18 a.m., Friday, June 6, 2008, in the Parkcenter Room, Doubletree Club Hotel, Boise, Idaho. Laura McGeorge, MD, Boise; Joyce McRoberts, public member, Meridian and Jerry Russell, Director, Idaho State Police, were absent and excused. Board staff present were: Nancy Kerr, executive director; Mary Leonard, associate director; Cynthia Michalik, quality assurance specialist; Beverly Kendrick, quality assurance specialist; Darlene Parrott, compliance monitor; Cathleen Morgan, Board counsel; and Jean Uranga, Board attorney.

In accordance with Idaho Code §67-2345 (b), (d) and (f), the Board moved to go into Executive Session at 10:18 a.m. (Motion Harf - Affirmed Marano, McClusky, Melendez, Sutherlin and Ellsworth)

In Executive Session, the Board reviewed and considered the recommendations of the Committee on Professional Discipline and the allied health boards.

MINUTES

Minutes of the Board meeting of March 7, 2008 regular meeting were approved with corrections. (McClusky/Unanimous)

Unless otherwise noted, all actions were taken on motions duly made and adopted unanimously.

ADMINISTRATION

Board members reviewed the financial report from the last Quarter.

Board members reviewed the draft of the summer 2008 newsletter. Laura McGeorge, MD, volunteered to write the Board member article. (Consensus)

The members reviewed the Physician Recovery Network (PRN) statistics and annual report.

The Federation of State Medical Boards (FSMB) representatives presented information on the services, structure and function of the FSMB.

Vice Chairman, David McClusky, II, MD, presented highlights of the Physician Assistant Subcommittee, which met on May 21, 2008. The key points of agreement among those present were:

1. Allow ownership of medical practices by physician assistants. The Board may designate additional form requirements in the delegation of services agreement for physician assistant practice owners and their respective supervising physicians.
2. Policy/rule/law for physician assistant medical practice ownership must be consistent throughout the state.
3. New/recent graduates from physician assistant training will be excluded from practice ownership for a specified period of time defined in policy/rule/law.
4. The Board will add additional questions/attestations to the physician assistant and supervising physician renewal form to address supervision and related concerns.
5. An alternate supervising physician must be registered for physician assistant owned practices at all times.

Following consideration and discussion the Board acted to accept the recommendations of the PA Subcommittee and directed staff to draft the necessary rule and/or statute changes for review at the next meeting. (Ellsworth/Unanimous)

Board members were informed that the terms of two public members, Joyce McRoberts and Matthew Ellsworth, were expiring and both were eligible for re-appointment. The members acted to recommend that both members be re-appointed. (Harf/Unanimous) In further action, the Board acted to affirm their ballot vote that Curtis Sandy, MD, be considered for re-appointment to the Emergency Medical Services Physician Commission (Harf/Unanimous) and Keith Davis, MD, be nominated for re-appointment to the Advanced Practice Nurse Advisory Committee. (Melendez/Unanimous)

Following consideration and discussion, the Board directed staff to contact the FSMB for references for the definition of the “active practice of medicine”. (McClusky/Unanimous)

The Board directed staff to obtain some examples of other state boards’ efforts to address the issue of “maintenance of licensure” and continued competency, for review at the next Board meeting. (Marano/Unanimous)

Staff indicated that a meeting would be rescheduled to discuss the proposed Uniform Volunteer Health Practitioners Act.

The Board considered a draft of proposed changes to IDAPA 22.01.01, Rules of the Board of Medicine for the Licensure to Practice Medicine and Surgery and Osteopathic Medicine and Surgery in Idaho. Based on member feedback changes were made to the malpractice history requirements consistent with the criteria established in the Patient Freedom of Information Act. The proposed changes will allow mutual recognition of licensure with a modified, abbreviated application process for those applicants that meet established criteria. The Board directed the staff to continue the rule promulgation process. (McClusky/Unanimous)

In consideration of the PA subcommittee recommendations, the members directed staff to combine the proposed rule changes to IDAPA 22.01.03, Rules for the Licensure of Physician Assistants, with the PA subcommittee revisions. (Marano/Unanimous)

LICENSURE

The members re-considered a request for deletion of certain public records from the Board of Medicine’s website. The Board acted to adhere to the Public Records law in this matter. (Ellsworth/Unanimous)

The Board acted to approve the request of Rocky Mountain Emergency Physicians for a waiver of number of physician assistants supervised and their plans for supervisory coverage of physician assistants. (Ellsworth/Unanimous)

In accordance with Idaho Code §67-2345 (b), (d) and (f), the Board moved to go into Executive Session at 1:20 p.m. (Motion Melendez - Affirmed Harf, Marano, McClusky, Ellsworth and Sutherlin)

In Executive Session, the Board reviewed applications, interviewed the applicants and provided an annual evaluation of the executive director.

The Board acted to leave Executive Session at 4:22 p.m. (Motion Melendez - Affirmed Harf, Marano, McClusky, Sutherlin and Ellsworth)

Applicants BOMA 1766, BOMA 1838 and BOMA 1722 failed to show for scheduled interviews.

The Board acted to approve the full, unrestricted licensure of applicant BOMA 1831. (Melendez/ Unanimous)

The Board acted to grant licensure with conditions to applicant BOMA 1988. (Melendez/ Unanimous)

The Board acted to grant licensure with conditions to PACA 432. (Harf/Unanimous)

The Board acted to obtain further investigation into identified discrepancies of the application of BOMA 1943. (Sutherlin/Unanimous)

The Board members rated the Executive Directors performance as Exemplary.

The Board reviewed minutes of the April 21, 2008 meeting of the Athletic Trainers Licensure Board and the March 14, 2008 minutes of the Occupational Therapy Licensure Board.

The Board acted to appoint Caroline Faure, AT, and Barrie Steele, AT, to the Board of Athletic Trainers. (Harf/Unanimous)

The members acted to appoint Paul Durham, RT, to the Respiratory Therapy Licensure Board. (Harf/Unanimous)
