December 5, 2008

MINUTES

Minutes of the Board meeting of September 12, 2008 regular meeting were approved as written. (McClusky/Unanimous)

Unless otherwise noted, all actions were taken on motions duly made and adopted unanimously.

ADMINISTRATION

Board members reviewed the financial report from the last Quarter.

Committee on Professional Discipline member, Bruce Miewald, MD, volunteered to write the Board member article. (Consensus)

Board members considered information submitted by the Citizens Advocacy Center. The members elected to take no action.

The members reviewed information on the Board's complaint and action history.

The Board acted to approve the interview policy as written and considered a staff proposal for a provisional temporary license to address rural hospital shortages. Following discussion and consideration, the members acted not to proceed on the provisional temporary license proposal. The members agreed that an interim interview committee, consisting initially of Boise area members, would be a more effective way to expedite physician applicants requiring interviews in situations where an urgent need is identified. The members directed staff to draft proposed criteria for applicants eligible for an interim interview based on community or agency need, the nature of discrepancy requiring interview, and the urgency of the need. (McGeorge/Unanimous) In further action, the Board identified Julia Bouchard, MD, A.C. Jones, MD, Laura McGeorge, MD, Leo Harf, MD, Ralph Sutherlin, DO, and Trudy Jackson, Public Member, as potential members of the initial committee. (McGeorge/Unanimous)

The members reviewed the Federation of State Medical Boards draft telemedicine policy.

The Board reviewed the pending amendments to IDAPA 22.01.01, Rules of the Board of Medicine for the Licensure to Practice Medicine and Surgery and Osteopathic Medicine and Surgery in Idaho and IDAPA 22.01.03, Rules for the Licensure of Physician Assistants.

Jean Uranga, attorney presented the draft legislation for physician assistants and a copy of the comments of the Idaho Association of Physician Assistants. (IAPA) Following discussion and consideration, the Board acted to adopt all of the suggestions of the IAPA with the exception of proposed Idaho Code §54-1807 A (4) that states in part the Board may require the personal presence of a physician when designated health care tasks are performed. The Board acted to leave this section of the proposed legislation unchanged. (McGeorge/Unanimous)

The members reviewed the proposed legislation to allow investigative subpoena authority. Staff was directed to pursue changes as drafted. (McGeorge/Unanimous)

The Board reviewed the draft definitions of the active practice of medicine and gave direction to staff on proposed content. Staff was directed to return with proposed language at the next meeting. (Marano/Unanimous)

Sandy Evans, Executive Director, Idaho State Board of Nursing and Tana Corey, Bureau Chief, Idaho Bureau of Occupational Licenses, presented information on pending legislation, rules and activities, and answered questions for Board members.

LICENSURE

The Board acted to approve the request of Jeffrey Keller, MD, for a waiver of the number of physician assistants supervised, and his plans for supervisory coverage of physician assistants. (McRoberts/Unanimous)

The Board acted to approve the request of Women's' Healthcare Associates for a waiver of the number of physician assistants supervised and their plans for supervisory coverage of physician assistants. (McRoberts/Motion Passed)

The Board reviewed the site visit evaluation by New York State of the Medical University of the Americas and acted to approve the school based on New York's approval of the program. (McGeorge/Unanimous)

After consideration and discussion of the information in Case Number 6256, the Board acted to refer the information to the Oregon Board of Naturopathic Examiners and the Arizona Attorney General, and to issue a cease and desist order. (McGeorge/Unanimous)

In accordance with Idaho Code §67-2345 (b), (d) and (f), the Board moved to go into Executive Session at 1:31 p.m. (Motion/McRoberts – Affirmed/Harf, Marano, McGeorge, McClusky, Sutherlin, Jackson, and Melendez)

In Executive Session, the Board reviewed applications, interviewed the applicants, and considered the findings and recommendations of the examining committee in Case Number 6141.

The Board acted to leave Executive Session at 4:22 p.m. (Motion/McRoberts – Affirmed/Harf, Marano, McGeorge, McClusky, Sutherlin, Jackson, and Melendez)

The Board acted to grant licensure with conditions to applicant BOMA 2331. (McGeorge/ Unanimous)

The Board acted to grant licensure subject to conditions precedent and subsequent to applicant BOMA 2284. (McGeorge/Unanimous)

After consideration and discussion with Board Counsel, the Board acted to accept the Examining Committee's findings and recommendations in Case Number 6141. The Board also acted to direct that the Respondent undergoes two (2) additional assessments to ensure the ability to practice medicine with reasonable skill and safety. (Marano/Unanimous)

The Board acted to approve the full, unrestricted licensure for applicant BOMA 2291, and to provide information to the applicant on the corporate practice of medicine and supervision of medical personnel. (Jackson/Motion Passed)
