PARTICIPATING:

The meeting was called to order at 9:35 a.m. by Chairperson, Amy Waselchuk, PA, Boise. Participating were Magen Schmidt, Coeur d'Alene and David Martin, PA, Pocatello. MINUTES:

The minutes of the Physician Assistant Advisory Committee's (PA Committee) August 24, 2012 meeting were approved. Unless otherwise noted, all actions were taken on motions duly made and adopted unanimously. (Motion- Waselchuk; Affirmed-Unanimous)

ADMINISTRATION:

The PA Committee reviewed their Financial Status Report. (No Action Required)

The PA Committee reviewed pending Rule change to add a temporary license for PA applicants whose application is complete pending results of their criminal background checks. The PA Committee acted to recommend that the fee for the temporary license be \$50. (Motion-Schmidt/Unan)

The PA Committee reviewed information regarding conflicting language in the Rules for the Licensure of Physician Assistants, IDAPA 22.01.03.043, Delivery of Medication and the Board of Pharmacy's regulations regarding Prescriber Drug Outlets. The PA Committee acted to recommend amending the PA Rules to assure consistency between Board of Medicine, Physician Assistant Rules and Board of Pharmacy Regulations. The PA Committee also requested Board staff to inform the Idaho Academy of Physician Assistants (IAPA) of any proposed Rule changes. (Motion-Martin/Unan)

Magen Schmidt was elected Chairman to replace Amy Waselchuk, whose second term will expire March 31, 2013. The PA Committee and Board staff expressed their appreciation for Amy Waselchuk's service to the PA Advisory Committee.

The PA Committee was informed of the IAPA's nominations for a new Committee member.
