

## MINUTES

### RESPIRATORY THERAPY LICENSURE BOARD MEETING

Boise, Idaho

Wednesday, October 28, 1998

#### PARTICIPATING:

The meeting was called to order at 9:00 a.m. by Becky Reagan, chairman. Participating were Terri Harbison, Hagerman; Christy Gallup, Boise and Steven Schaal, RT, Gooding. Also present were Nancy Kerr, associate director; Darlene Parrott, technical records specialist and Eileen Wilson, clerical specialist. Gary Aiman, Rexburg, was absent.

#### MINUTES:

The minutes of the April 14, 1998 meeting were approved. Unless otherwise noted, all actions were taken on motions duly made and adopted unanimously.

#### BUSINESS:

Correspondence to the Joint Commission Home Care Accreditation Services was reviewed regarding the initial set-up of home health care equipment. Board counsel clarified the Board's position that, since 1994, non-licensed personnel may deliver and set up home oxygen equipment as long as there is no education other than basic equipment operation and safety or patient evaluation performed.

The board reviewed a position paper from the American Sleep Disorders Association regarding unlicensed technologists performing polysomnography testing which includes the use of CPAP. The Board determined that the use of CPAP constitutes the practice of respiratory care and would require a respiratory care license.

Becky Reagan gave a report on her attendance at the NBRC annual meeting. The NBRC will change the national examination to computerized testing in January, 2000, resulting in an increase in the cost of the examination, instant score reporting and greater accessibility for testing.

The Board of Medicine's strategic plan was reviewed.

The Board considered information regarding a new company, Dale K. Bean and Associates, wanting to provide home study continuing education courses in Idaho. The Board acted to maintain the current requirement that home study courses must be approved by the AARC.

The Board acknowledged that Terri Harbison's and Christy Gallup's terms expire December 31, 1998, and expressed its appreciation for their dedication and support during their commission as members of the Board.

The meeting was adjourned at 10:50 a.m..

LICENSURE:

In accordance with Idaho Code, section 67-2345 (b), (d) and (f), the board moved to go into executive session at 9:55 a.m..

Carolyn Fontaine appeared before the full board for a personal interview. The board acted to defer approval for licensure pending successful completion of either the certification or registry examination.

Information regarding unlicensed practice was reviewed. No action was warranted.

The board acted to leave executive session and go into open session at 10:40 a.m..
