RESPIRATORY THERAPY LICENSURE BOARD  
MEETING

Boise, Idaho

Thursday, February 24, 2011

PARTICIPATING:

The meeting was called to order at 10:03AM by Chairperson Richard White, RT, Hayden. Participating were Diana Lincoln-Haye, RPSGT, RT, Kimberly; Paul Durham, public member, Boise; Carrie Massey, RT, Blackfoot; and Marilyn Shuler, public member, Boise. Also attending were Mary Leonard, associate director; Beverly Kendrick, quality assurance investigator; Darlene Parrott, compliance monitor; and Jodi Adcock, technical records specialist I.

MINUTES:

The minutes of the September 23, 2010 meeting were approved. Unless otherwise noted, all actions were taken on motions duly made and adopted unanimously. (Motion-Shuler; Affirmed-Unanimous)

BUSINESS:

The Respiratory Therapy Licensure Board (RTL Board) acted to set their next meeting date for October 20, 2011, at 10:00AM. (Motion-White; Affirmed-Unanimous)

The RTL Board was informed that no nominations had been made for the vacancy of public member. Public member, Paul Durham will stay on the RTL Board until that vacancy can be filled.

The RTL Board reviewed a question regarding intravenous access by respiratory therapists. The RTL Board determined that, if properly trained, the administration of a peripherally inserted central catheter (PICC) is within the scope of practice of a respiratory therapist. (Motion-Shuler; Affirmed-Unanimous)

In accordance with Idaho Code, section 67-2345 (b), (d) and (f), the Respiratory Therapy Licensure Board (RTL Board) moved to go

into Executive Session at 10:55AM. (Motion-Durham; Approved-Unanimous)

The RTL Board acted to leave executive session and go into open session at 12:23PM. (Motion-White; Approved-Unanimous)

In open session the RTL Board voted on the following:

Interviewed applicant RESA-921. The RTL Board acted to approve applicant for licensure contingent on the signing of a Stipulation & Order. (Motion-Lincoln-Haye; Affirmed-Unanimous)

Application RESA-905 was reviewed. Applicant was unable to attend in person or by conference call. Due to unavailability of applicant, the RTL Board was unable to issue permit at this time. The RTL Board acted to require applicant to attend next RTL Board meeting in person for interview. The RTL Board also requested that the Board of Medicine attorney draft a request for applicant to stop practice in Idaho until permit is issued. (Motion-White; Affirmed-Unanimous)

Case #10-6651. The RTL Board acted to recommend closure and a confidential Letter of Advisement sent to licensee. (Motion-Massey; Affirmed-Unanimous)

Case #10-6063. The RTL Board acted to recommend closure. (Motion-Shuler; Affirmed-Unanimous)

The RTL Board was updated regarding current license, permit, and exemption count. Respiratory Therapist: 764; Respiratory Therapy Student Exemption: 146; Polysomnographic Trainee: 9; Polysomnographic Technician: 30; Polysomnographic Technologist: 66.

The RTL Board was provided with their board's current financial report.
