RESPIRATORY THERAPY LICENSURE BOARD
MEETING

Boise, Idaho
Thursday, March 8, 2012

PARTICIPATING:

The meeting was called to order at 10:02 A.M. by Chairperson Richard White, RT, Hayden. Participating were Diana Lincoln-Haye, RPSGT, RT, Kimberly; Paul Durham, public member, Boise; Carrie Massey, RT, Blackfoot; and Marilyn Shuler, public member, Boise. Also attending were Mary Leonard, associate director, Cathleen Morgan, Board counsel and Jodi Adcock, technical records specialist I. Michael Brennen, RPSGT, of the Board of Registered Polysomnographic Technologists was present during the discussion of polysomnography exams. Cynthia Michalik, quality assurance investigator was present during the discussion of Case RES-2011-493.

MINUTES:

The minutes of the October 20, 2011 meeting and December 12, 2011 conference call were approved. Unless otherwise noted, all actions were taken on motions duly made and adopted unanimously. (Motion-Massey; Affirmed-Unanimous)

BUSINESS:

The RTL Board reviewed information from the American Board of Sleep Medicine (ASBM) and Board of Registered Polysomnographic Technologists (BRPT) regarding their exams for certification of polysomnography technologists. Upon deliberation and discussion, the RTL Board acted to not accept the ASBM exam as an equivalent to the BRPT exam at this time. (Motion-D Lincoln-Haye; Affirmed-Unanimous)

The RTL Board discussed possible Rule changes to not allow polysomnography technicians that do not pass the BRPT within the allowed duration of their permit to re-apply as a trainee.

Upon deliberation and discussion, the RTL Board acted to deny a request to "back date" a technician permit. (Motion-White; Approved-Unanimous)

The RTL Board acted to request Board staff conduct a CE audit following the completion of the 2012-2013 renewal cycle. Audit is to be random, but will include licensees that have been reviewed by the RTL Board. (Motion-Massey; Approved-Unanimous)

In accordance with Idaho Code, section 67-2345 (b), (d) and (f), the Respiratory Therapy Licensure Board (RTL Board) moved to go into Executive Session at 12:35 P.M. (Motion-Durham; Approved-Unanimous)
